- 1. THE MEETING WAS CALLED TO ORDER BY LISA VAN LIEW AT 7:34 P.M.
- 2. THE ROLL CALL WAS TAKEN. VAN LIEW, PRESENT, DUNN, PRESENT. GREEN, ABSENT. OWENS, PRESENT. HALL, PRESENT. A QUORUM WAS PRESENT.
- 3. THE MINUTES OF THE AUGUST MEETING WERE PRESENTED TO THE BOARD. HALL MADE A MOTION TO ACCEPT THE MINUTES AS PRESENTED. OWENS SECONDED THE MOTION. VAN LIEW YEA, DUNN YEA, HALL YEA, OWENS YEA.
- 4. THE FINANCIAL REPORT WAS READ BY ALL MEMBERS PRESENT. HALL MADE A MOTION TO ACCEPT THE REPORT AS PRESENTED. OWENS SECONDED THE MOTION. VAN LIEW YEA, DUNN YEA, HALL YEA, OWENS YEA.
- 5. TO DISCUSS AND CONSIDER APPROVAL OF OLD BUSINESS:
  - A. DISCUSSION AND POSSIBLE ACTION REGARDING PROPOSED IMPROVEMENTS FOR INCREASED FUTURE UTILIZATION OF TOWN PROPERTY. OWENS SPOKE WITH COEDD AND OLSEN ENGINEERING FIRM REGARDING PROPERTY IMPROVEMENTS. COEDD INFORMED HIM OF A TRANSPORTATION ALTERNATIVE PROGRAM GRANT. OWENS WILL GET TOGETHER THE INFORMATION NEEDED FOR THE GRANT AND THE TOWN WILL HOLD A SPECIAL MEETING BEFORE THE SEPTEMBER 30 APPLICATION DEADLINE TO DECIDE IF THEY WANT TO APPLY FOR THE GRANT.

SECTION 307(B)(4) REGARDING CONFIDENTIAL COMMUNICATION BETWEEN THE BOARD OF THE TOWN OF PINK AND ITS ATTORNEY CONCERNING A POTENTIAL LAWSUIT REGARDING CERTAIN DEVELOPER'S CONTINUED NONCOMPLIANCE WITH THE TOWN ORDINANCES, OF WHICH DISCLOSURE WILL SERIOUSLY IMPAIR THE ABILITY OF THE BOARD TO LITIGATE SAID LAWSUIT.   - D. DISCUSSION AND POSSIBLE ACTION REGARDING TOWN DUMP DAY/COMMMUNITY YARD SALE. VAN LIEW MENTIONED IT HAS BEEN SCHEDULED FOR OCTOBER 8 FROM 8:00 AM UNTIL 1:00 PM OR WHEN THE DUMPSTERS ARE FULL.
