- 1. THE MEETING WAS CALLED TO ORDER BY LISA VAN LIEW AT 7:39 P.M.
- 2. THE ROLL CALL WAS TAKEN. ALL TRUSTEES WERE IN ATTENDENCE. A QUORUM WAS PRESENT.
- THE MINUTES OF THE LAST MEETING WERE PRESENTED TO THE BOARD. VAN LIEW MADE A MOTION TO ACCEPT THE MINUTES AS PRESENTED. GREEN SECONDED THE MOTION WITH A PROPOPSAL TO CORRECT THE PREVIOUS FEBRUARY MINUTES ON 5B WITH \$900.00 FOR METER AND \$7,500.00 FOR RUNNING WATER LINES. VAN LIEW YEA, GREEN YEA, HALL YEA, DUNN YEA, EMERT YEA.
- 4. THE FINANCIAL REPORT WAS READ BY ALL MEMBERS PRESENT. GREEN MADE A MOTION TO ACCEPT THE REPORT AS PRESENTED. EMERT SECONDED THE MOTION. VAN LIEW YEA, GREEN YEA, HALL YEA, DUNN YEA, EMERT YEA
- 5. TO DISCUSS AND CONSIDER APPROVAL OF OLD BUSINESS:
 - A. RURAL WATER HOOKUP: ALLEN KIDWELL BID \$4,000.00 TO RUN THE LINES WITH \$900.00 FOR THE TOWN HOOK UP. GREEN MADE A MOTION TO HAVE THE RURAL WATER DISTRICT SET THE METER. AFTER THE METER IS SET, GET ALLEN KIDWELL TO SET THE LINES. VAN LIEW SECONDED THE MOTION. VAN LIEW YEA, GREEN YEA, HALL YEA, DUNN YEA, EMERT YEA.
 - B. NEW DOOR LOCK INSTALATION: EMERT MADE A MOTION TO USE DON'S MOBIL SHOP INC. TO INSTALL THE NEW DOOR LOCKS. GREEN SECONDED THE MOTION. VAN LIEW YEA, GREEN YEA, HALL YEA, DUNN YEA, EMERT YEA.
- 6. TO DISCUSS AND CONSIDER APPROVAL OF NEW BUSINESS:
 - A. CREDIT CARD AUTHORIZATION TO BUY NEEDED FIRE DEPARTMENT SUPPLIES: ROB STATED THAT BECAUSE OF A RECENT FIRE, WE NEED A CREDIT CARD THAT WE CAN USE TO GET NEEDED SUPPLIES SO THE FIRE DEPARTMENT CAN BE UP AND RUNNING THE NEXT DAY. GREEN MADE A MOTION TO RAISE THE CURRENT GAS CARD AMOUNT TO \$5,000.00 AND NOT LET IT GET BELOW \$2,000.00. VAN LIEW SECONDED THE MOTION. VAN LIEW YEA, GREEN YEA, HALL YEA, DUNN YEA, EMERT YEA.
- 7. ITEMS THAT HAVE COME UP THAT WERE U.NFORESEEN PRIOR TO THE AGENDA POSTING: A. NONE.
- 8. TO HEAR PUBLIC COMMENTS:
 - A. MIKE GREEN: HE STATED THAT CLOSE TO HIS HOUSE, A TRAILER HOUSE HAS BEEN MOVED IN ACROSS THE DRIVEWAY OF AN EMPTY HOUSE. IT HAS BEEN THERE FOR SOME TIME. ROB VAN LIEW STATED THAT HE WOULD LIKE TO PUT A NEW PUMP ON ONE OF THE TRUCKS. HE WOULD LIKE FOR IT TO BE A DIESEL PUMP INSTEAD OF A GAS

THERE IS ONE NEW FIRE FIGHTER THIS MONTH. HE SAID THAT HE NEEDS 3 NEW RADIOS AND NEW GEAR FOR THE NEW FIRE FIGHTERS. HALL MADE A MOTION TO GET THE CLOTHES AND RADIOS AND SPEND UP TO \$10,000.00. GREEN SECONDED THE MOTION. VAN LIEW YEA, GREEN YEA, HALL YEA, DUNN YEA, EMERT YEA.
