1. THE MEETING WAS CALLED TO ORDER BY LISA VAN LIEW AT 7:36 P.M.
2. THE ROLL CALL WAS TAKEN. DUNN, ABSENT. VAN LIEW, PRESENT. GREEN, PRESENT. MILLER, PRESENT. HALL, PRESENT. A QUORUM WAS PRESENT.
3. THE MINUTES OF THE DECEMBER MEETING WERE PRESENTED TO THE BOARD. GREEN MADE A MOTION TO APPROVE THE DECEMBER MEETING MINUTES. MILLER SECONDED THE MOTION. VAN LIEW YEA, GREEN YEA, MILLER YEA, HALL YEA. MOTION PASSES.
4. THE DECEMBER FINANCIAL REPORT WAS READ BY ALL MEMBERS PRESENT. MILLER MADE A MOTION TO ACCEPT THE REPORT. HALL SECONDED THE MOTION. VAN LIEW YEA, GREEN YEA, MILLER YEA, HALL YEA. MOTION PASSES.

A. FIRE DEPARTMENT:

CHIEF VAN LIEW WAS ABSENT, BUT THE DECEMBER FIRE REPORT AND 2025 CALENDAR YEAR FIRE REPORTS WERE PRESENTED. IN THE MONTH OF DECEMBER, THE FIRE DEPARTMENT RESPONDED TO 12 CALLS – 8 FIRES AND 4 MEDICAL CALLS. FOR CALENDAR YEAR 2025 THE FIRE DEPARTMENT RESPONDED TO 190 CALLS – 95 FIRES, 62 MEDICAL CALLS, 3 HAZARDOUS CONDITION CALLS, 1 SERVICE CALL, 15 GOOD INTENT CALLS, AND 14 FALSE ALARMS.
