 - A. MOWING TOWN PROPERTY: DUNN GAVE A DESCRIPTION OF THE MOWING RESPONSIBILITIES. THEY ARE: MOWING, WEED EATING, TRIMING TREES HIGH ENOUGH FOR THE TRACTOR TO GO UNDER THEM AND KEEPING THE EQUIPMENT IN GOOD WORKING ORDER. THE MOWER WILL BE PAID \$350 PER MOWING. DUNN WILL DETERMINE WHEN IT NEEDS TO BE MOWED. THE MOWER WILL NEED TO HAVE LIABILITY INSURANCE IF HE IS HURT AND A BOND IF THE PROPERTY IS DAMAGED. HE WILL ALSO NEED MEDICAL INSURANCE. IF THE MOWER IS A PINK VOLUNTEER FIRE FIGHTER, HE WILL HAVE WORKERS COMP INSURANCE THAT WILL TAKE CARE OF THE INSURANCE AND BOND. DUNN MADE A MOTION TO HIRE TRAVIS ROOP FOR THE JOB. HE IS A FIRE FIGHTER. EMERT SECONDED THE MOTION. VAN LIEW YEA, HALL YEA, DUNN YEA, EMERT YEA.
- 7. ITEMS THAT HAVE COME UP THAT WERE U.NFORESEEN PRIOR TO THE AGENDA POSTING: A. NONE.
- 8. TO HEAR PUBLIC COMMENTS:

- 9. TO HEAR REPORTS FROM OFFICERS, BOARDS AND COMMITTEES:
 - A. FIRE DEPARTMENT (ROB VAN LIEW): THERE WERE 20 RUNS DURING APRIL. THEY WERE: 12 MEDICAL CALLS, 2 MOTOR VEHICLE ACCIDENTS, 3 GRASS FIRES, 1 SMOKE INVESTIGATION AND 2 MUTUAL AID CALLS.

SOME OF THE FIRE FIGHTERS WENT TO WESTERN OKLAHOMA ON THE LARGE GRASS FIRES. ROB SAID THAT WHEN A FIRE FIGHTER GOES ON A LONG RUN, THEY NEED TO STAY OVER NIGHT BECAUSE THEY ARE TO TIRED TO DRIVE AT THAT TIME.

3 RADIOS, CHARGING UNITS AND PROGRAMING LABOR: HALL MADE A MOTION TO BUY THE RADIOS, CHARGING UNITS AND HAVE THEM PROGRAMMED. THEY
