THE TOWN ATTORNEY ADVISED THE BOARD THAT THE DEPARTMENT OF TRANSPORTATION OF THE STATE OF OKLAHOMA REQUESTED THE TOWN TO EXECUTE A DEED CONVEYING THE CONDEMNED PORTION OF THE PROPERTY THAT WAS CONVEYED TO THE TOWN BY HEARTLAND ACRES IN ORDER TO CLEAN-UP TITLE FOR THAT TRACT. UPON REVIEW, DUNN MADE A MOTION TO APPROVE THE TOWN'S EXECUTION OF THE DEED. MILLER SECONDED. GREEN, YEA. HALL, YEAH. DUNN, YEAH. MILLER, YEA. MOTION PASSES.

- B. DISCUSSION REGARDING OIL AND GAS WELL PERMIT APPLICATION AND VARIANCE APPLICATION SUBMITTED BY CULBREATH OIL & GAS CO., INC.

THE TOWN ATTORNEY ADVISED THE COUNCIL REGARDING THE OIL AND GAS PERMIT APPLICATION AND APPLICATION FOR VARIANCE FROM ORDINANCE NO. 16 SUBMITTED BY CULBREATH OIL & GAS CO., INC. THE TOWN ATTORNEY SPECIFICALLY ADVISED THAT THE APPLICATION REQUESTED A VARIANCE FROM THE 660 FOOT SETBACK REQUIREMENT AND THE SUBDIVISION RESTRICTION CONTAINED IN ORDINANCE NO. 16, AND THAT ORDINANCE NO. 16 PROHIBITS AN EXCEPTION FOR AN OIL AND GAS PERMIT IN A SUBDIVISION. REPRESENTATIVES OF CULBREATH PRESENTED THE GROUNDS FOR CULBREATH'S APPLICATION FOR PERMIT AND VARIANCE AND ANSWERED QUESTIONS OF THE COUNCIL. THE COUNCIL REVIEWED THE APPLICATION AND STATUTES PRESENTED BY REPRESENTATIVES OF CULBREATH. THE COUNCIL NOTED THAT NO WRITTEN APPROVAL OF ANY PROPERTY OWNER WITHIN THE SUBDIVISION WAS SUBMITTED WITH THE APPLICATION AND THAT THE TERMS OF ORDINANCE NO. 16 WOULD PREVENT AN EXCEPTION IN A SUBDIVISION. GREEN MADE A MOTION TO TABLE THE MATTER TO A SPECIAL MEETING TO BE HELD NOVEMBER 20, 2025, AT 7:00 P.M. DUNN SECONDED. GREEN, YEA. HALL, YEAH. DUNN, YEAH. MILLER, YEA. MOTION PASSES.
